Panel Cydnabyddiaeth Annibynnol Cymru: sy'n rheoli lwfansau sy'n daladwy i aelodau etholedig Cynghorau Cymuned a Thref. Mae Cyngor Cymuned Ystrad Fflur yn perthyn i Grŵp C, yn seiliedig ar ei ffigurau incwm a gwariant, sy'n adlewyrchu'n well, lefelau gweithgarwch cyngor yn hytrach na chymarebau poblogaeth, yn ôl canfyddiadau'r Panel. Mae Cynghorau Tref a Chymuned Grŵp C wedi'u hawdurdodi i gynnig taliad o £150 i bob un o'u haelodau yn flynyddol am gostau ffôn, technoleg gwybodaeth, nwyddau traul ac ati. Mae gan Gynghorau Cymuned a Thref Grŵp C yr awdurdod i wneud taliad blynyddol o £500 yr un i 5 aelod i gydnabod cyfrifoldebau penodol. Mae hyn yn ychwanegol i'r taliad o £150 am gostau a threuliau os honnir hynny. Rhaid i bob cyngor cymuned a thref ddarparu ad-daliad costau angenrheidiol i ofalu am blant ac oedolion dibynnol (a ddarperir gan ofalwyr anffurfiol neu ffurfiol) ac ar gyfer cymorth personol y mae ei angen hyd at uchafswm o £403 y mis. - 1. CHAIRMAN'S WELCOME**
The Chairperson Cllr Gareth Owen extended a warm welcome to all present.
PRESENT:

- 2. APOLOGIES**
Apologies for absence were received from Councillor Angharad Jones (due to illness) & Cllr Clare Hughes (due to illness).
- 3. READING OF THE MINUTES OF MAY 2018**
The Minutes were read and were unanimously agreed to be a correct record. Proposed by Cllr. Doug Rowbotham; seconded by Cllr. Alun Price Jones and **RESOLVED** unanimously that they were an accurate record.
- 4. SIGNING OF THE MINUTES OF MAY 2018**
The Minutes were signed by the Chairperson Cllr. Gareth Owen.
- 5. RENEWING THE CLERK'S POWER TO ACT WHEN FACED WITH ISSUES WHICH ARISE BETWEEN MEETINGS AFTER CONSULTATION WITH THE CHAIRPERSON AND VICE-CHAIRPERSON –**
RESOLVED to continue with the arrangement.
- 6. CHAIRPERSON'S ALLOWANCE: RESOLVED** to continue with the present

allowance of £200 for the Chairperson. Receipts to be submitted.

PROPOSED by Cllr John Jones and **SECONDED** by Cllr Laura Jones.

Independent Remuneration Panel for Wales: has powers over the allowances payable to elected members of Community and Town Councils. Ystrad Fflur Community Council falls into Group C, based on its income and expenditure figures, which better reflect the activity levels of a council than population ratios, according to the findings of the Panel. Community and Town Councils in Group C are authorised to make available a payment to each of their members of £150 per year for costs incurred in respect of telephone usage, information technology, consumables etc. Community and Town Councils in Group C are authorised to make an annual payment of £500 each to up to 5 members in recognition of specific responsibilities. This is in addition to the £150 payment for costs and expenses if that is claimed. All community and town councils must provide for the reimbursement of necessary costs for the care of dependent children and adults (provided by informal or formal carers) and for personal assistance needs up to a maximum of £403 per month. Reimbursement must be for the additional costs incurred by members in order for them to carry out their approved duties. Reimbursement shall only be made on production of receipts from the carer.

It was unanimously **RESOLVED** not to subscribe to the above during the previous AGM and many Cllrs have informed the Clerk in writing that they do not wish to receive the annual allowance of £150.

7. MATTERS ARISING FROM THE MINUTES

7.1 Minute 9.2 Inclusion of Community Council minutes within the Village's Web site- it had not been possible to do this. The County Council had been approached to ask whether it was possible to include a link of Ystrad Fflur Community Council within the website of the County Council but no decision had been reached.

Cllr Laura Jones was thanked for setting up the website for Ystrad Fflur Community Council www.ccystradfflurcc.co.uk during the past year. It is a legal requirement that Minutes/Agendas and certain documents of the Community Council are available on-line.
