4. POLICE MATTERS

7.1 Former building: St David's Church, Pontrhydfendigaid: It was reported that the Church building had been sold STC. Approximately 80 questionnaires had been

completed and returned, Chair Cllr Gareth Owen will collate the responses and compile a written report, which will be circulated to members of the Community Council. Cllrs will then be able to glean from the responses, the facilities, which will be required in the Village.

- 7.2 **Fence for the Park:** Cllr Clare Hughes is exploring sources of funding.
- 7.3 **Rospa Annual Inspection of Pantyfedwen Play Area:** scheduled for June 2021. Cllr Clare Hughes and Chair Cllr Gareth Owen to attend to matters arising from the 2020 Rospa Report. Laura Jones to liaise with Cllr Clare Hughes re grant sourcing.
- 7.4 **Problem of pig manure in the environs of Ffair Rhos.** Had been drawn to the attention of the Environmental Health Dept, Ceredigion County Council via County Cllr Ifan Lloyd Davies. It was reported that a County Council Official had visited the area.
- 7.5 **Gates to replace stiles at Ffair Rhos:** it was reported that Mr Haydn Lewis, Rights of Way and Countryside Ranger, Ceredigion County Council had executed some of the work to include the stile previously positioned on the footpath leading from Glasfryn to Rhos Helyg.

- 8.3 **Building a healthier future after COVID – 19: Have your say**

Hywel Dda University Health Board is asking the people of Carmarthenshire, Ceredigion and Pembrokeshire to help it further shape and deliver future services by taking part in a six-week engagement exercise.

Since the publication of its strategy, A Healthier Mid and West Wales: Our Future Generations Living Well in 2018, the Health Board has worked with partners to provide care and develop services.

However, the coronavirus pandemic has had a major impact on health and care services. As a result, the Health Board now wants to learn from the public about how the pandemic has affected their health and care, and access to it.

Hywel Dda UHB is also asking for the public's feedback in relation to its long-term strategy to develop and build a new hospital in the south of the Hywel Dda area, somewhere between and including St Clears, in Carmarthenshire, and Narberth, in Pembrokeshire. This location is the most central for most of the population in the south of the Hywel Dda area, and it was determined through the public consultation held in 2018.

The engagement exercise will run from Monday 10th May until 21st June 2021.
