**Village Defibrillators**

Two defibrillators were registered on the Circuit, one adjacent to the Shop and one in close proximity to the Pantyfedwen Hall.

Batteries were currently flat and required monitoring every month. Ceredig was the nominated caretaker of the Shop's Defibrillator.

Clare Hughes was unanimously elected to assume the role of caretaker for the defibrillator of the Village Hall.

Cllr Elgan Williams enquired whether it would be possible to position a defibrillator in the environs of Ffair Rhos. It was agreed to look into the matter.

## **5. POLICE MATTERS**

Police Community Support Officer John Evans updated members on recent events within the locality.

Fraud/ Scam calls: - continue.

A car's number plate had fallen off/ been taken on purpose.

Traffic issues within the Village were discussed.

County Cllr Ifan Lloyd-Davies reported that investigations were ongoing regarding reducing the speed limit from 30mph to 20mph within the Village's speed restriction Zone.

Regarding parking, imposing restrictions proved a challenge as most motorists preferred to park in front of their homes.

It was agreed to invite a representative of Dyfed-Powys Police to a future meeting of the Community Council to discuss the situation regarding the sentencing of an Ystrad Meurig individual, for a serious offence. PCSO John Evans was also asked to look into the matter, in view of its severity and deep public concern.

**8.2 It had been reported to** Ceredigion CC in a previous meeting that trees needed to be trimmed in close proximity to Tyllyn, Ffair Rhos.

**A reply was received from the owner of Tyllyn asking for more clarification.**

Cllr Gareth Owen had discussed the matter with the owner and a resolution had been reached.

**8.3 Litter Pick:** Tuesday 26<sup>th</sup> April 2022 @ 5pm. It was agreed to thank members of the public, for helping to collect litter around the village on the 26<sup>th</sup> of April and also to the Red Lion for providing food after the event, without imposing a fee. It was resolved to arrange another litter collection before the National Eisteddfod.
