MINUTES OF THE MONTHLY MEETING
18.05.2023 IMMEDIATELY AFTER THE ANNUAL GENERAL MEETING
PANTYFEDWEN HALL LIBRARY, PONTRHYDFENDIGAID**

DISCUSSION RE THE PARC TEIFI DEVELOPMENT

The Chair, Cllr Angharad Jones welcomed Christine Major (CM), Commercial Director, The Original Travel House LTD, to the meeting to discuss future plans for the Parc Teifi Development. Parc Teifi comprises a cluster of ten holiday cottages within the Village of Pontrhydfendigaid. It is marketed through the Original Travel House Ltd, a family run business based at Swansea with fifteen branches throughout South Wales.

There could be a change of use for this development from "Holiday Lets" to another status. CM explained that the complex was busy during the summer to include the staging of the National Eisteddfod 2022 at Tregaron but at other times bookings proved a challenge. The chalets were advertised on social media and Bont Fb.

Government grants had been provided during the Covid-19 Pandemic but the site was running at a loss. The income in 2022 had been approximately £80,000, which had not covered costs.

Possible future plans for Parc Teifi

1. A Planning Application could be made to the Local Authority requesting a change of use for the cottages e.g., from "holiday let" to "residential". They could then be sold as residential properties.
2. Women's Refuge
3. Over 55 years of age – assisted living

It was asked whether people living in these homes in a full-time capacity, whether purchasing on the open market, an user of a refuge centre or assisted living would contribute to the fabric and culture of the Village.

4. Affordable housing was much needed, especially for Young People, who were currently priced out of the market by other buyers and many were leaving the area. According to Ceredigion County Council, Parc Teifi was not the right fit for affordable housing as e.g., it was not based in a town and many facilities were unavailable e.g., one pub had closed and another one offered limited services.

The Community Council deemed Affordable housing for local people the best option.

The question was put to the Community Council

Does the Community Council support the request for a change of use?

Answer: No.

The situation will be discussed at Ceredigion County Council's Chamber but should the change of use from holiday let to residential come to pass, The Community Council wished to ask Ceredigion CC to research the legalities of only selling to the local market i.e., to include a clause that the seller could only sell to local people.

Moreover, the Community Council only supported affordable housing and not social housing.

County Cllr Ifan Lloyd Davies will convey the Community Council's stance to Ceredigion CC.

3. APOLOGIES FOR ABSENCE

4. POLICE MATTERS

PCSO John Evans reported the following issues, which had arisen during the past month:

Sometime over the weekend 06-05-23 to 08-05-23 damage had been caused to a Vauxhall Vivaro works van which was parked in Heol y Bannau, Bont. The offenders had tried breaking into the van by way of cutting a hole through the back. The owner did not believe any items had been stolen.

Sometime between 2100 hrs Sunday, 07-05-23 and 1500 hrs Monday, 08-05-23 a catalytic converter had been stolen from a Mazda MX 5 which was parked outside a house in Heol y Bannau, Bont

*Violence/ Assault : zero

*Fraud/ Scam calls :-

During May,2023 there had been an increase in telephone calls to residents in Ceredigion from persons purporting to be from the Metropolitan Police. The person claiming to be a police officer informed the victim (person taking the call) that they had a named person in custody who had been arrested for cash machine frauds. The arrested person was in possession of the victim's personal details and the police officer wished to confirm these details.

The aim of this fraud was to then progress to obtaining details of victim's bank account and bank card details or to inform victim that arrangements will be made to collect the bank card (Courier Fraud)

** To date three such reports had been reported to DPP by residents residing in the Tregaron Policing area. – no financial loss had resulted.

DPP Economic Crime Team members had spoken to the victims and provided advice and this had been followed up by visits from NPT (Neighbourhood Policing Team) The incidents had been reported to Action Fraud.

7. MATTERS ARISING

7.1 Pantyfedwen Play Area: A Site Meeting had taken place on Tuesday 4th April at 10.30am under the direction of Stefano Antoniazzi (SA), Ceredigion County Council, Cllr Gareth Owen and Mrs Clare Hughes. Mats were required. SA had stated that match-funding was necessary when applying for a grant. Grants could be available to meet the match-funding e.g., for a grant of £10,000, the match-funding of £10,000 could be met by another grant. SA *to find out*. Grants could be available via the National Lottery.

ROSPA Play Inspection 2023: will take place in June £75 + VAT.

The tourist information sign: to be positioned within the Hall Premises. Cllr Elgan Williams will execute the task.

7.2 National Lottery Grant: further attention will be assigned to the conditions of the Grant to meet certain projects within the Village.

7.3 Defibrillator at Teifi Inn , Ffair Rhos

The total of defibrillators within Ffair Rhos and Bont was now four.

Village Shop, Bont

Strata Florida Abbey. (Community Council had provided the box)

A discussion took place regarding another defibrillator, which could be located in the area. It was agreed to ask the Headteacher of Bont School, whether the defibrillator could be installed on the school premises, the Carpark. Chair Angharad Jones to ask Joyce.

7.4 Main Bridge of the Village: It was reported that the Traffic Lights were often out of operation with long queues on either side.

7.5 Flags: Ffair Rhos: Cllr Ieuan Davies to purchase.

7.6 Reports of Sub-Committees

7.6.1 Hall Committee: It was reported that the Community Council met the cost the Pantyfedwen Hall's annual audit in its capacity of Custodian Trustee of the Hall.

7.7 Two vacancies in the office of Councillor Ystrad Fflur Community Council, Gwnnws Uchaf Ward: CCC had been informed of the vacancies. A Public Notice had been displayed in the vicinity inviting ten electors of the electoral area of Ystrad Fflur Community Council (Gwnnws Uchaf Ward) to request an Election to fill the vacancies, by notice in writing addressed and delivered to the Returning Office, Neuadd Cyngor Ceredigion, Penmorfa, Aberaeron on or before 20.04.2023. There

were no requests for an Election. Ystrad Fflur Community Council can now co-opt 2 members. A "Notice of Co-option" will be displayed locally inviting expressions of interest by the 15.06.2023.
