1. CHAIRPERSON'S WELCOME AND PERSONAL MATTERS

Chair Cllr Elgan Williams welcomed all to the meeting.

Members were saddened to hear of the recent passing of Mr Aneurin Jones, Pontrhydygroes, the brother of Cllr Richard Jones. A minute's silence was observed in memory of Mr Aneurin Jones and it was agreed to forward the Community Council's condolences to the family.

3. APOLOGIES

Cllr Mel Briant, Cllr Angharad Jones, and Cllr Richard Jones apologised for their inability to attend the meeting.

4. POLICE MATTERS

PCSO John Evans provided the following information re police matters for the past month:

Bikes to include two quad bikes, had been driven at excess speed through the Villages of Llangeithio, Tregaron, and Pontrhydfendigaid. It was believed that the drivers were from the Liverpool area. Two camping vans had been parked at Ffair Rhos, which had, by now, moved on.

A great deal of litter had been left outside the Village Shop.

Parking problems had been encountered in the environs of the Red Lion.

Lorries had travelled at excess speed on Abbey Road.

5. DECLARATION OF PERSONAL AND PREJUDICIAL INTEREST: None declared.

6. CONFIRMATION OF THE MINUTES OF THE 15th MAY 2025

It was **PROPOSED** (Cllr Ieuan Davies); **SECONDED** (Cllr Gareth Owen) and **RESOLVED** that the Minutes of the 15th May 2025 were a correct record and were signed by the Chairperson.

7. MATTERS ARISING

7.1 Pantyfedwen Play Area

7.1.1 It was AGREED to apply for the Ceredigion Play Provision Capital Grant.

The Welsh Government had provided Ceredigion CC with capital funding to improve play opportunities in Ceredigion.

Requests for funding must include:

1. Plans to consult with local children, young people, and parents.
 2. Plan or Policy to make sure the play space is accessible to disabled children and adults who live in the area.
 3. Clear and concise costings for the project delivery.
 4. Relate the application to the Ceredigion Play Sufficiency Assessment 2025-28.
- A maximum of £13,500 capital grant was available per project. 10% match funding required for the project.

Application forms must be returned to Matthew Roebuck by Friday 27th June 2025.

Cllr Gareth Owen, Project Manager. Grant to cover Liquid Pour (priority), Swing Extension, Slide, Gates. Two quotes required. To seek the assistance of Rosemary Whinnett to complete the Grant Application.

7.1.2 The implications of the RoSPA Annual Inspection Report June 2025 were considered. The fence positioned between the Play Area and the Football Field required attention, according to the Report. To inform Cllr Richard Jones.

7.2 New bus-stop at Ffair Rhos

Cllr Ieuan Davies had located a suitable bus-shelter. To secure a parcel of land on which the bus-shelter could be positioned. It was agreed to arrange a site meeting with a representative of Ceredigion CC to discuss the matter further. Awaiting a reply from the Highways/ Planning Depts, Ceredigion CC.

7.3 Trimming of Ash Tree on the Village Green: ongoing.

7.4 Grit Bin: Cwrtywern: It will be necessary for a representative of Ceredigion CC to inspect the proposed site for the bin to establish its feasibility. If suitable, it was agreed to purchase the grit/ sand. Awaiting for a representative of Ceredigion CC to contact Cllr Richard Jones to discuss further.

7.5 Ffair Rhos Fair: A committee had met to discuss the feasibility of reintroducing the former Fair at Ffair Rhos. A small event was considered for 2025.

7.6 Signs – Keep Tidy: it was reported that dog faeces proved a hazard at certain locations within the Village. Signs *No Dogs* to be placed adjacent to the Pavilion and on the Village Green.
Cllr Richard Jones to assign attention to the purchase of suitable signs to encourage dog owners to dispose of dog faeces in a responsible manner.

- 7.7 Village Maintenance Day to be arranged. A list of works required.**
Vegetation/overgrowth proved a concern in the environs of Rock House. Cllr Mel Briant to ask in relation to the trimming of the hedge – no developments during this meeting.
- 7.8 Floral Displays within the Village:** Nathan had provided displays at both entrances to the Village and at the entrance to the Pantyfedwen Hall. The Community Council to meet the cost. Anne and Jane to assume responsibility for the display at Ffair Rhos.
- 7.9 Biodiversity Section 6:** The responsibility of the Community Council: Cllr Mel Briant to assign attention to the document.
- 7.10 Old Well of the Village:** Cllrs Elgan Williams and Gareth Edwards will represent the Community Council at the site meeting of Thursday 3rd July 2025 at 2pm. Mr Jim Cowie, Mr Chris Harris, and a Natural Resources Wales Officer were also expected to be present.
The well was currently surrounded by fencing of extremely poor condition, which could prove a hazard, especially for young children.

7.11 Parc Teifi Complex

A response was received from Merron Vance, Executive Assistant | Swansea.com in relation to the Community Council's enquiry regarding the current situation appertaining to the sale of properties within Parc Teifi

It was explained that the houses were now listed for sale with Morgan and Davies, which could be viewed on the link: .

The clubhouse will be converted into 4 flats, as per planning, and these will then also be listed for sale under Section 106 Agreement for affordable housing.

The Community Council was unaware of past/present local interest in purchasing the properties.

7.12 Response received from Natural Resources Wales (NRW) re the wildfires at Ffair Rhos Pontrhydfendigaid and Cwm Elan

NRW referred to the area as the Tywi Forest - the fire appeared to have started on April 6, 2025, on private land near the forest owned by NRW and the cause of the fire was unknown. Over time, the fire spread until it covered an area of over 5,500 hectares, mainly private land. The fire entered forests managed by NRW and the Fire and Rescue Services requested helicopter assistance for NRW land due to difficulties in dealing with the fire using conventional techniques. The helicopter was on site for five days along with a location in the Rheidol Valley. NRW staff also supported the Fire and Rescue Services with access to the forest and the surrounding private land. Altogether, the Tywi wildfires damaged a mix of replanted sites, mature trees, and habitat restoration work covering an area of about 100ha. The broader 5,000+ hectares outside of direct NRW control was the responsibility of the land ownership for dealing with fires in these areas.

7.13 Matters presented by members of the public during the May AGM

- 7.13.1 A stile was** required on the footpath at the Bryn Gors Caravan Park.
- 7.13.2 Footpath from the Primary School to Ffair Rhos:** a gate was required along this route.

- 7.13.3 Footpath along the river in the vicinity of Dolebolion:** in need of maintenance – to inform Eifion Jones Ceredigion CC.
- 7.13.4 Previous “Public Conveniences” building at Bont.** Trees are overgrown in the vicinity. A streetlight was necessary at this location and by “Arhosfa.”
- 7.13.5 Lôn Fach:** street light necessary at the start and end of the Lane. Grass in need of cutting at Lôn Fach, an area which, formally had been dealt with, by Ceredigion CC. It had been agreed at the AGM for Cllr Ifan Davies to arrange a site meeting with Brian, Highways Dept Ceredigion CC in relation to 7.13.4 & 7.13.5.

8.2 Appointments to the Ceredigion Local Access Forum

Providing access to Ceredigion’s coast and countryside was an essential part of the rural tourism product in Ceredigion and the network of public rights of way was a valuable economic asset that created jobs. What is more, countryside access had a key role to play in health and well-being. Regular walking, cycling and horse riding could bring benefits through improving people’s health and well-being.

The Ceredigion Local Access Forum was set up under the Countryside and Rights of Way Act 2000 to advise the County Council, Natural Resources Wales, and others on the way that access to the countryside could be improved and managed. The Forum was a statutory body encouraged to set its own agenda.

Local Access Forums represented a broad spectrum of interests and the Council was currently seeking enthusiastic people to sit on the Forum and play a key role in improving and managing access to the County’s diverse and attractive countryside. The Forum was appointed for a three-year term.
